		Injury to spectators	P=2 S=3 =6	Spectators are not allowed on ramps. Designated spectator areas are side & front end of the building. There are steps by the entrance to the toilets and that have been 'ramped' for disabled access. Viewing area stairs have a hand-rail fitted.	N/A
		Litter on ramps	P=2 S=2 =4	There are bins provided. Staff pick up litter from around park areas to ensure all areas are clean & safe.	Daily – staff
		Damage to ramps	P=4 S=2 =8	Ramps are checked daily as per daily ramp check procedures. Minor damage is monitored, repairs are carried out on maintenance days. Any major damage identified would result in ramps being closed.	Periodically - 4-1-4 ramp builders
